Camper Terms & Conditions

By signing this statement, you acknowledge that certain activities of the camp programs are physically demanding and inherently dangerous. It is impossible to anticipate all of the hazards campers might encounter while hiking, canoeing, swimming, participating in lake activities (ie, lake toys, Wet Willie water slides, diving boards, etc.), playing basketball, volleyball, dodgeball, Giant Swing, using the high ropes course, and other physical activity around camp. Some of these might include: slipping or falling on the trail, bumps, bruises, cuts, insect bites, poison ivy, sprains, fractures or other injuries. The camp staff will take every reasonable precaution to minimize exposure to known risks.

The camper and parent/guardian(s) (I/We) acknowledge the nature of the activity and the fact that not all of the stresses and hazards connected with the activity can be foreseen.

Knowing the inherent risks, dangers and rigors involved in the activities, I/we acknowledge that our camper is capable of participating in the activities.

Camp Akita is located in a wooded area that includes forests, grasses, lakes, streams, and wildlife, and inherit risks therein. Examples of wildlife encounters might include but are not limited to spiders, mosquitoes, bees, ticks, bats, fish, raccoons, mice, deer, and snakes. I/We acknowledge said risks and assume any medical expense incurred due to an encounter with wildlife, including any costs not covered by insurance.

It is the camper's responsibility to follow the established safety rules and procedures for each activity. If at any time the camper has questions about the activity, it is the camper's responsibility to consult with a staff member.

I/We understand that pictures and/or quotes of campers may be used by First Community Church/Camp Akita in promoting and/or celebrating the summer camp ministry. I/We give permission to First Community Church/Camp Akita to use any photographs or quotes of our camper(s) for any legal use, including but not limited to: publicity, copyright purposes, illustration, advertising, and web content.

I/We give permission for our camper to be transported in First Community Church/Camp Akita rented vehicles (school bus) and/or First Community Church/Camp owned vehicles.

I/We assume full responsibility for bodily injury, death, loss of personal property and expenses thereof, as a result of camper's negligence.



Physical violence or threats during participation by a camper is strictly prohibited. The Directors reserve the right, at their discretion, to withdraw any camper whose influence or actions are deemed dangerous or disruptive to the experience of other campers and staff, or are not living within the rules and policies of First Community Church/Camp Akita. Should this occur, no reduction or return of fee, or any part thereof will be made. Parent/Guardians will also be responsible for any additional costs associated with returning their child home early.
